Georgia Transportation Legislation passed!

During CREW's April program with Tad Leithead, Chairman of the Atlanta Regional Commission (ARC), Tad identified transportation as one of the top three sustainable growth issues for the Atlanta Metro Area. In the subsequent weeks, you received emails from CREW Atlanta's Public Policy Initiative (PPI) encouraging outreach to state representatives in support of the transportation-funding bill.

On Wednesday, April 21st, both the Georgia House and Senate passed the Georgia 2020 Transportation Act by an astounding majority: The House passed it by a vote of 141-29 and the Senate by a vote of 43-8. We are excited to share this triumphant milestone for Atlanta's future growth and economic prosperity with you.

Community-based project selection process In 2012, voters within each of the twelve Georgia regions will vote on levying a one-cent sales tax to raise funds for highway and transit projects in their respective regions.
